§8. Management consultant

MultiPark plans to hire a management consultant, Thomas Sewerin, to help with suggestions on how to improve the organizational and communicational structure.

- §9. New infrastructure working group & recommendation to separate organization of the experimental and clinical/health science infrastructures
 - -A new experimental infrastructure working group has been created to help organize the experimental infrastructures.
 - -The organization of the experimental and clinical/health science infrastructures has been separated to easier set the structural organization in place. The deadline to have the structure in place should be before the next board meeting in autumn.
- §10. Travel grants to virtual travel grants

Travel grants will be granted for virtual conferences as well.

§11. Other issues

- MultiPark clinical research nurses have during 2020 been required by the hospital for clinical work due to the COVID-19 pandemic and therefore they have been unable to perform all their research assignments as planned. The board strongly supports the clinical work performed by these research nurses in these exceptional times. Therefore, the board *decided* that MultiPark funding for 2020 but not used because of the pandemic, can be used during 2021 in order to complete such delayed clinical research studies.
- A *decision* was made regarding adjunct members attending the board meetings:
 - -To have the same adjunct members during 2020; Gesine Paul-Visse and Tomas Deierborg.
 - -The board will decide at the start of each board meeting whether the
